## Information according to Article 13 GDP

In connection with the receipt of your personal data, which is processed pursuant to Article 6(1)(b) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter referred to as "GDPR") - the processing is necessary for the performance of a contract to which you are a party, we inform you pursuant to Article 13 GDPR as follows:

- The purposes of the processing for which your personal data is intended are keeping subcontractor records for the purpose of fulfilling customer-supplier contracts and obligations under the Commercial Act and other regulations; processing personal data for the purpose of protecting property and health; processing personal data for the purpose of asserting legal claims.
- The legal basis for processing your personal data is the contract to which you are a party (Article 6(1)(b) GDPR)
- Your personal data may be transferred to other recipients. These recipients also provide sufficient and credible guarantees on the technical and organizational security of the protection of your personal data
- The data controller does not intend to transfer your personal data to a third country or an international organization.
- Your personal data will be stored for as long as necessary to comply with a legal obligation.
- You have the right to request access to your personal data from the data controller in accordance with Article 15 of the GDPR - to obtain confirmation from the controller as to whether your personal data is being processed and, if it is, to obtain access to that personal data and the following information:
  - processing purposes,
  - the categories of personal data concerned,
  - the recipients of your personal data,
  - the intended period for which your personal data will be stored or, if this cannot be determined, the criteria used to determine this period,
  - the existence of the right to request the controller to rectify or erase or restrict processing or to object to processing,
  - the right to lodge a complaint with a supervisory authority,
  - any available information on the source of the personal data, if any, the fact that automated decision-making, including profiling, is taking place and, at least in such cases, meaningful information concerning the procedure used as well as the significance and foreseeable consequences for you of such processing
- You have the right to request the data controller to correct your personal data in case of
  inaccuracies in accordance with Article 16 GDPR, you have the right to have your personal data erased
  under the conditions set out in Article 17 GDPR
- You have the right to restrict the processing of your personal data in accordance with Article 18 GDPR
- In case of doubts about compliance with the obligations related to the processing of your personal data, you have the right to lodge a complaint with the Office for Personal Data Protection, located at 27 Pplk. Sochora Street, 170 00 Prague 7 pursuant to Article 77 GDPR
- The provision of your personal data is a contractual requirement or a requirement to be included in a contract, and you are not obliged to provide personal data. Failure to provide your personal data will mean that the controller will not be able to conclude the contract with you.
- There is no automated decision-making decisions based solely on automated processing of personal data, including profiling.
